- These seats will be **against higher fee category** and is admissible to candidates from all over India.
- For higher fee category, **reservation policy is not applicable.**
- The admissibility will be based **strictly on merit (i.e. % of marks secured in PCB/PCMB/PCM/Inter-Agriculture)** in **10+2 examination** except B.V.Sc. & A.H. programme which will be based on marks scored in **Entrance Test only** as per VCI guidelines. The date & venue of the Entrance Test shall be intimated to the candidates at the time of issue of **Online Admit Card.**
- Indian National who have attained **16 years** of age as on 31<sup>st</sup> August, 2020 [for B.Sc. (Hons.) Agriculture/Horticulture/ Forestry, B.Tech. (Food Tech./ Agril. Engg.) & B.F.Sc. programmes] and **17 years** of age as on or before 31<sup>st</sup> December, 2020 (for B.V.Sc. & AH programme) are eligible to apply. No relaxation is admissible regarding the minimum age limit.
- The admission fee for 1<sup>st</sup> Year; 1<sup>st</sup> Semester (for all the degree programmes except BVSc & AH) will be **Rs. 54,380/- (Rupees fifty four thousand three hundred eighty)** only (including tuition fee of **Rs. 50,000/-**) and from the 2<sup>nd</sup> Semester onwards, it will be **Rs. 53,080.00 (Rupees fifty three thousand eighty)** only.

However, for **B.V.Sc. & AH candidates**, admission fee for 1<sup>st</sup> Year will be **Rs. 2,56,360/- (Rupees two lakh fifty six thousand three hundred sixty)** only per year/annum (including tuition fee of **Rs. 2,50,000/- per year/annum**) and from 2<sup>nd</sup> Year and subsequent years onwards, it will be **Rs. 2,55,060.00 (Rupees two lakh fifty five thousand and sixty)** only per year/annum.

- The students admitted under this Higher Fee Category **shall not be eligible for any financial benefits** such as scholarships, stipend, internship and any other grants from the University. However, all other facilities will be provided at par with the other State/ICAR nominees
- Any additional vacancy that may arise in any degree programme to be filled up from this category shall be at the discretion of the Selection Committee and subsequent approval of the competent authority

**Step – 1:** All applicants must create respective accounts on the portal and submit the application.






