Viz, EAST KHASI HILLS DISTRICT, WEST KHASI HILLS DISTRICT, SOUTH WEST KHASI HILLS, WEST JAINTIA HILLS DISTRICT, RI- BHOI DISTRICT, WEST GARO HILLS DISTRICT AND SOUTH WEST GARO HILLS DISTRICT AND SOUTH WEST

The Government of Meghalaya through the Department of Agriculture & Farmers Welfare vide office Order No. AGRI(G)54/2014/59 Dated: 9th August, 2022 stated that fertilizer will be made available at statutorily fixed price as determined by the Ministry of Chemical's and fertilizers in a controlled manner only to the selected pockets in the 7 (Seven) Districts of the State mentioned above, to protect the interest of those farmers using fertilizer. In view of this, the Government vide letter No. AGRI(G)23/2021 Dated: 8th December, 2022 directed to float an EOI for the purpose of retail licencing of fertilizers, therefore, in accordance to the Govt's orders an EOI has been issued to invite applications from interested Retail dealers for application of licence for the purpose of sale or carrying on business of chemical fertilizers as **RETAIL DEALER** in 7 (Seven) Districts of Meghalaya. Viz, East Khasi Hills District, West Khasi Hills District, South West Khasi Hills, West Jaintia Hills District, Ri- Bhoi District, West Garo Hills District And South West Garo Hills Districts.

Interested Dealers are invited to submit their applications based on the following eligibility criteria:

A. PRE-QUALIFICATION CRITERIA

The Directorate of Agriculture shall issue licence for the purpose of sale or carrying on business of chemical fertilizers as **Retail Dealer** to dealers who fulfil the following criteria:

- 1. The applicant shall either be a single entity or joint venture/consortium, registered as a Private/Public Limited Company, Partnership Firm, Limited Liability Partnership, Society or Autonomous Organization under respective acts in India.
- 2. Dealers must be registered in India with appropriate tax (GST) registration.
- 3. The applicant should furnish an undertaking to the effect that the He / She has not been black listed.

Note: Documentary Support for all the above shall be submitted.

B. DOCUMENTS TO BE FURNISHED

Application duly affixed with recent pass port size photo shall be accompanied with

- 1. Memorandum of intimation FORM 'A1'{See clause 8 (2)} of the Fertilizer (Control) Order 1985.
- 2. Form 'O' from source as per the Fertilizer (Control) Order 1985. In cases where fertilizers are obtained for sale from different sources, a certificate of source from each such source shall be furnished in Form 'O'.
- 3. Fees of Rs. 1500/- to be deposited via **Treasury** *Chalan* in favour of the Director of Agriculture and *chalan* in duplicate shall be furnished with the application.
- 4. Details of sale depot i,e Location of the sale depots and location of go downs attached to sale depot along with photographs duly verified by the respective DAOs.
- 5. Analysis report of fertilizers from the concerned company.
- 6. NOC or Trading licence from Municipality/Autonomous councils.

- 7. Address proof & identity proof (PAN card, Aadhar card & Epic).
- 8. Copy of the wholesaler certificate.
- 9. Dealership Certificate.
- 10. Attested copy of GST.

Note:

- 1. Self-Attested copies of Supporting Documents shall be furnished.
- 2. Form 'A 1' enclosed.

C. REFUSAL OF CERTIFICATE OF REGISTRATION

- 1. If applicant's previous Certificate of registration is under suspension or
- 2. If applicant's previous Certificate of registration has been cancelled within a period of one year immediately preceding the date of application or
- 3. If applicant has been convicted of the offence under the Act, or any order made there under within three years immediately preceding the date of application or
- 4. If applicant fails to enclose with the application a certificate of source or
- 5. If the applicant is incomplete in any respect or
- 6. If the applicant makes an application for obtaining the Certificate of registration for industrial dealer and excepting if He is a manufacturer, importer or pool handling agency hold an authorization letter for wholesale dealer or retail dealer or both and as the case may be, the vice versa.

D. TERMS AND CONDITIONS

- 1. Period of validity of the Certificate of Registration /licence granted shall be valid for a period of 5 Years from the date of its issue.
- 2. The applicant shall follow the Fertilizers Control order 1985 and the updated amendment from time to time.

E. CLARIFICATIONS & AMENDMENTS

1.
